**UNDERTAKING**

**(Section 154, Business Practices and Consumer Protection Act)**

**WHEREAS** the undersigned 0735706 BC Ltd., dba BC Truck & Auto Sales is a "supplier" within the meaning of subsection 1(1) of the *Business Practices and Consumer Protection Act*;

**AND WHEREAS** the Registrar of Motor Dealers (the "Registrar") has reason to believe that the suppliers are contravening, are about to contravene or have contravened the *Business Practices and Consumer Protection Act* or the regulations made thereunder, namely:

**ALLEGATIONS:**

On or about June 18, 2007 at or near the city of Surrey in the province of British Columbia that the supplier, 0735706 BC Ltd., dba BC Truck & Auto Sales did commit or engage in a deceptive act or practice by representing in writing and by their conduct to the consumer Bhupinder Sahota, that the motor vehicle, namely a 2003 Honda Pilot VIN: 2HKYF18563H55842, is of a particular standard and quality and used exaggeration, innuendo or ambiguity about a material fact or that fails to state a material fact if the effect is misleading specifically disclosed that the motor vehicle has sustained damages over \$2,000.00 when in fact the vehicle was a rebuilt motor vehicle from the U.S.A. and required a safety and structural integrity inspection before the motor vehicle could be registered in British Columbia; contrary to section 5 (1) of the Business Practices and Consumer Protection Act S.B.C. 2004 c.


**NOW THEREFORE** the undersigned:

1. Hereby undertakes:
  - (a) To comply with the *Business Practices and Consumer Protection Act* and the regulations made thereunder;
  - (b) To refrain from engaging in the following deceptive acts or practices:
    - (i) misleading consumers by not disclosing all material facts about and the vehicle
    - (ii) misleading consumers by not ensuring a clear explanation of the contents of all documents required to be signed by a consumer;
2. Furthermore, the undersigned hereby agrees;
  - (i) To pay the consumer, Bhupinder Sahota, the agreed sum of \$1,500.00; and

- (ii) To reimburse to the Registrar a total of \$1,979.77 for inspection/investigating and legal costs relating the subject matter of this Undertaking,

**THE UNDERSIGNED** hereby acknowledges, represents and declares that they have each read this Undertaking and have had a reasonably opportunity to obtain independent legal advice as to its terms.
