**IN THE MATTER OF THE MOTOR DEALER ACT
AND THE BUSINESS PRACTICES AND CONSUMER PROTECTION ACT**

UNDERTAKING

(Section 154, Business Practices and Consumer Protection Act)

VSA Files: 12-70237

WHEREAS the undersigned Dee Kay Holdings Limited DBA D.K. Motors (D.K. Motors) and Ashok Dhaul are each a "supplier" within the meaning of subsection 1(1) of the *Business Practices and Consumer Protection Act*;

AND WHEREAS the Registrar of Motor Dealers (the "Registrar") has reason to believe that the supplier is contravening is about to contravene or has contravened the *Business Practices and Consumer Protection Act* (BPCPA) or the regulations made thereunder, namely:

Section 5(1) BPCP: (Sections 4(1) and 4(3)(a)(i to viii) 4(3)(b)(i to ix) and/or 4(3)(c)(i to iii) and or Section 9(1).

AND WHEREAS the Registrar of Motor Dealers (the "Registrar") has reason to believe that the supplier is contravening is about to contravene or has contravened the Motor Dealer Act or the regulations made thereunder, namely:

Section 3.1(b) of the Motor Dealer Act, section 6(c), 21(2) (e) and (f), 22 and 27 of the Motor Dealer Act Regulation.

Item #1

Between April 4, 2012 and April 6, 2012, both dates inclusive at or near the city of Victoria in the Province of British Columbia, Dee Kay Holdings Limited DBA D.K. Motors (D.K. Motors) and Ashok Dhaul (the "Suppliers") did in relation to a consumer transaction contravene sections 4, 5, 8 and 9 of the Business Practices and Consumer Protection Act (BPCPA) by making an oral, written, visual, descriptive or other representation or conduct by the Suppliers in an offer of sale to Daryl Dunn (the "Purchaser") that had the capacity, tendency or effect of misleading consumers in general and the Purchaser specifically:

The Suppliers allowed Jason Coburn to take a 2003 Toyota Echo VIN #JTDBT123535051417 ("the Motor Vehicle") belonging to the Suppliers and which Coburn:

(a) misrepresented the condition of the Motor Vehicle and the previous history of the Motor Vehicle to the Purchaser; and

(b) offered to sell the Motor Vehicle away from the Supplier's registered business premises without obtaining the prior approval of the Registrar.

DHAUL **AND WHEREAS** Dee Kay Holdings Limited DBA D.K. Motors (D.K. Motors) and Ashok Dhual are desirous of resolving this matter without the need for any formal adjudication of the above allegations.

DHAUL **AND WHEREAS** Dee Kay Holdings Limited DBA D.K. Motors (D.K. Motors) and Ashok Dhual has completed a system review of its operations and made procedural changes satisfactory to the Registrar.

DHAUL **NOW THEREFORE** Dee Kay Holdings Limited DBA D.K. Motors (D.K. Motors) and Ashok Dhual each undertakes:

- a) To comply with the *Business Practices and Consumer Protection Act* and the regulations made there under;
- b) To ensure all material facts are disclosed to consumers prior to purchase of any motor vehicle;
- c) To comply with the Motor Dealer Act and the regulations;
- d) To comply with the Motor Vehicle Act and the regulations.

AND THEREFORE the undersigned



- a) Dee Kay Holdings Limited DBA D.K. Motors undertakes to reimburse the Registrar a total of \$1,175.66 for inspection/investigation and legal costs relating to the subject matter of this Undertaking; and
- b) Dee Kay Holdings Limited DBA D.K. Motors undertakes to pay an Administrative Penalty in the amount of \$500.00 in relation to the issue covered in this undertaking.

THE UNDERSIGNED hereby acknowledges, represents and declares that he has read this Undertaking and has had a reasonable opportunity to obtain independent legal advice as to its terms.

THE UNDERSIGNED further hereby acknowledges that the availability of an undertaking to resolve any future similar allegations or contraventions may be unavailable; and that

any similar allegations may be reviewed by the Registrar of Motor Dealers at a formal hearing to consider the allegations.
