UNDERTAKING

(Section 154, *Business Practices and Consumer Protection Act*)

VSA Undertaking File: 16-10-002**

WHEREAS the undersigned Super Sale Auto Ltd. (Dealer #40285) is a "supplier" within the meaning of subsection 1(1) of the *Business Practices and Consumer Protection Act*, S.B.C. 2004, c. 2.

AND WHEREAS the Registrar of Motor Dealers (the "Registrar") has reason to believe that the supplier has contravened subsections 4 and 5 of the of the *Motor Dealer Act* [RSBC 1996] Chapter 316 (the "MDA") as follows:

1. Super Sale Auto Ltd. consigned a motor vehicle to a consumer without having a condition on their licence to conduct consignment sales.
2. Super Sale Auto Ltd. sold a motor vehicle to a consumer that was determined to be unsafe and did not meet the requirements of Section 222 of the Motor Vehicle Act.

AND WHEREAS Super Sale Auto Ltd. is desirous of resolving this matter without the need for any formal adjudication of the above allegations.

NOW THEREFORE:

Super Sale Auto Ltd. (Dealer #40285) undertakes:


1. To comply with the *Business Practices and Consumer Protection Act* and the regulations made thereunder;
2. To comply with the *Motor Dealer Act Regulation*, the *Motor Vehicle Act* and the Regulations made thereunder;
3. To have all vehicles offered for sale inspected to ensure that they meet safety standards of the Province of British Columbia. These inspections are to be documented and kept on the Dealer file for the review of the Vehicle Sales Authority.

4. To pay an Administrative Penalty in the amount of \$3,000.00 in relation to the subject matter of this Undertaking.
5. To reimburse the Registrar a total of \$500.00 representing 100% of the inspection/investigation and legal costs incurred to date in relation to the subject matter of this Undertaking.

THE UNDERSIGNED hereby acknowledges, represents and declares that he or she has read this Undertaking and has had a reasonable opportunity to obtain independent legal advice as to its terms.

THE UNDERSIGNED further hereby acknowledges that the Registrar may decline to accept an undertaking to resolve any future similar allegations or contraventions; and that any similar allegations may be reviewed by the Registrar of Motor Dealers at a formal hearing to consider the allegations.
