Wholesale Auction Requirements Motor Dealer Act Amendments, Part 5

Conditions needed to be exempt from licensing

The *Motor Dealer Act (MDA)* has always provided a licensing exemption for wholesale auctions. The recent amendments to the MDA added conditions that must be met for a wholesale auction to keep that exemption. The Registrar can remove the exemption if an auction:

- Fails to offer only *eligible motor vehicles*
- Does not ensure only *eligible bidders* and *eligible sellers* have access to the auction by using visible photo identification
- Fails to control access to the bidding floor and to electronic bidding
- Does not keep auction records for at least two years
- Fails to allow the Registrar, or an authorized person, access to the *auction records*
- Does not allow the Registrar, an authorized person, or a peace officer access to the facility

What is an eligible bidder?

- A licensed motor dealer
- A licensed wholesaler
- ICBC or an insurer insured under the *Insurance* Act

What is an eligible seller?

- A licensed motor dealer or licensed wholesaler
- ICBC or an insurer insured under the Insurance Act
- The Province of British Columbia
- A liquidator
- A person disposing under a Repairer's Lien
- A manufacturer or exporter
- A bailiff or lender of money

What is an eligible motor vehicle?

- A used vehicle offered for sale on behalf of an eligible seller
- A vehicle in which the auction and its officers, directors, or employees have no property interest
- A vehicle for which the seller makes the standard declarations, including if the vehicle is "not suitable for transportation," available to bidders in writing
