## Compliance Activities October 1—December 31, 2019

This quarter included five Decisions of the Registrar and eight Compliance Undertakings. These undertakings involved deceptive acts and practices, breach of prior undertaking, unlicensed salespeople, and curbing. Activities in the past three months also included responding to over 1,024 enquiries from consumers, closing 136 investigations with consumer restitution over \$547,375. All formal compliance activities are posted on the VSA website within seven days of the decision date. Previous compliance activity reports are also available on the VSA website and may be a useful tool for dealers to evaluate their current business practices.
